With due respect, I am producing herewith the 04 (four) arrested accus Matigation Flamely Sanjay Karjee (35 yrs), S/O- Jaleshwar Karjee of near Lal Sadhu sonar dam, Purba Rantigur Holina Colling, Slot- Darjeeling, 2] Sunil Subba (24 yrs), S/O- Chitra Kr. Subba of Ashoke Nagar, Cllege more, Gosaipur, PS- Bagdogra, Dist-Darjeeling, 3] Surja Barman (19 yrs), S/O- Lankeshwar Barman of Parimal Nagar, PO+PS- Matigara, Dist-Darjeeling (A/P- Mulaijote, Gosaipur, PS- Bagdogra, Dist-Darjeeling), and 4] Moksedul Alam (25 yra), S/O- Lt. Md. Sagir of Noukaghat Porajhar, PS- NJP, Dist- Jalpaiguri and the following articles under seizure:-

1. One iron made hammer from the possession of accused named Sanjay Karjee.

2. One iron made die measuring approximately 2 feet from the possession of accused named Sunil Subba.

3. One iron made shabol measuring approximately 3.5 feet from the possession of accused named Surja Barman.

4. One hacksaw blade with handle and one torch light from the possession of Moksedul Alam.

I, ASI Chandra Prakash Adhikari of Matigara PS, Siliguri Police Commissionerate beg to state that on 18.09.2025 at 23:25 hrs, I received a secret source information that a gang of miscreants were assembled at Begunbari under Matigara T.E beside Sun nursing home, PS- Matigara, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Kadamtola under Matigara PS area. Accordingly, I informed the fact to you and diarized the matter vide Matigara PS GDE No- 789, Dated- 18.09.2025. As per kind order myself along with PSI Avijit Banik, ASI Dipak Kr. Chhetri, C/219 Sanatan Chitrakar, C/868 Sujal Roy, C/523 Sanjit Kundu all are of Matigara PS, Siliguri Police Commissionerate left for Begunbari under Matigara T.E beside Sun nursing home, PS- Matigara, Dist.- Darjeeling to work out the information in hand. At about 23:30 hrs on 18.09.2025 we arrived at Begunbari under Matigara T.E beside Sun nursing home, Matigara PS. After arrival of the spot and as identified by the source we found that 11/12 persons were assembled in a dark place at Begunbari under Matigara T.E beside Sun nursing home, PS- Matigara, Dist- Darjeeling and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended four (04) persons of them. On interrogation the apprehended accused persons, they disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there to commit dacoity in a house at Kadamtola under Matigara PS area. They also stated that others 07/08 associates were able to fled away from the spot by taking advantages of darkness. On being searched of the apprehended accused persons, found the above noted articles. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 04 (four) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made in between 23:38 hrs to 23:57 hrs on 18.09.2025. The whole process of seizure was made under videography and the video was made by PSI Avijit Banik of Matigara PS, SPC.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely 1] Sanjay Karjee (35 yrs), S/O-Jaleshwar Karjee of near, PS- Matgara, Dist- Darjeeling, 2] Sunil Subba (24 yrs), S/O-Chitra Kr. Subba of Ashoke Nagar, Cllege more, Gosaipur, PS- Bagdogra, Dist- Darjeeling, 3] Surja Barman (19 yrs), S/O-Lankeshwar Barman of Parimal Nagar, PO+PS- Matigara, Dist- Darjeeling (A/P- Mulaijote, Gosaipur, PS-Bagdogra, Dist- Darjeeling), and 4] Moksedul Alam (25 yra), S/O-Lt. Md. Sagir of Noukaghat Porajhar, PS-NJP, Dist- Jalpaiguri and others and arrange for its investigation.
