**Subject:** Complaint against Mr. **Chanchal Mandal** for damaging my property, harassing our female staff, and threatening me and my husband Mr. **Chandra Prakash Sharma**.

Respected Sir,

I am the owner of **The Blue Eye Sweets 'n Café & Restaurant**, Ground Floor, **Om Aditya Apartment**, Shaktigarh Road No. 4, Siliguri.

On 16.09.2025 at around 12:34 AM, a man named **Chanchal Mandal**, son of **Chitta Mandal**, resident of Road No. 7, Shaktigarh, Siliguri, attacked my café and damaged our property. He was abusing me, my husband, and my staff. He dragged and tried to turn over the food stall standing in front of the café, damaged it, and also broke our signboard worth ₹65,000. He threw stones at the shutter gate and caused damage here and there. The total damage is around ₹90,000.

He also gave threats to my staff and me with dire consequences. Not only did he create havoc, but he also harassed our female staff with inappropriate and vulgar comments while passing across the road.

Furthermore, Mr. **Chanchal Mandal** threatened me and my husband with dire consequences if we raised any objection or reported the matter. His actions have caused us mental trauma, financial loss, and fear for our safety.

I therefore request you to kindly register this complaint at the earliest, investigate the matter, and take strict legal action against **Mr. Chanchal Mandal** to ensure our safety and prevent such incidents in the future. I have CCTV footage as proof and many eyewitnesses.
