With due respect and humble submission I ASI Prabir Roy of Matigara P.S. beg to submit that today on 19/09/2025 myself along with force were detailed to perform Mobile Patrol duty, vide C.C. No. 2539/25, Dated 19/09/2025 and GDE No. 811, Dated 19/09/2025 from 14:00 hrs. During my said mobile van duty, at about 19:05 hrs, I received a source information that one Truck loaded with river bed material is coming towards Khaprail More from Rananagar side under P.S. Matigara having no document/Royalty in respect of said load. Accordingly 1 informed the matter to I/C Matigara P.S., over phone. After hearing the information he directed me to work out over the information at once. Accordingly I along with force rushed to Sutki Godown, dry fish market, under Matigara P.S. and found one Truck bearing No. WB78/7133 loaded with riverbed materials is coming towards Khaprail More, accordingly we detained the said Truck. On demand the driver of said Truck namely Rabi Das (34) S/O Lt. Sukra Das of Tumbajote, P.S.- Matigara, Dist.- Darjeeling could not produce any valid documents in respect of said load. It may be presumed that the Driver/Owner of said Trauck procured the loaded riverbed materials, illegally and dishonestly, stealing by unfair means from elsewhere and proceeding to deliver the same to their designated customer for their wrongful gain. Finding no other alternatives, I seized the said Tractor bearing no. WB78/7133, loaded with riverbed materials, preparing proper Seizure List also arrested the driver namely Rabi Das (34) S/O Lt. Sukra Das of Tumbajote, P.S.- Matigara, Dist.- Darjeeling. Search and Seizure and arrest were made in between 19:00 hrs to 19:15 hrs hrs on 19/09/2025 under proper videography.

Therefore, I pray before your kind honour that a specific case may kindly be registered against the Driver of Truck bearing no, WB78/7133 namely Rabi Das (34) S/O Lt. Sukra Das of Tumbajote, P.S.- Matigara, Dist.- Darjeeling, loaded with riverbed materials, and arrange for it's investigation.
