In producing herewith arrested accuseds namely (i) Adhhiraz Duraj (20) S/O Suraj Duraj of Deocothapath, Bijanbari, P.S.- Pulbazar, Dist.- Darjeeling (ii) Adhish Uprety (23) S/O Samir Uprety of Babubasha, Debidanga, Champasari, P.S.- Pradhannagar, Dist.- Darjeeling (iii) Avishek Pradhan (36) S/O Late Balaram Pradhan of Deocothapath, Bijanbari, P.S.-Pulbazar, Dist.- Darjeeling (iv) Kanstab Prasad (25) S/O Anil Prasad of Gurung Busty, Durga More Colony, Ward No. 3, P.S.- Pradhannagar, Dist.- Darjeeling, arrested u/s 35 of BNSS from infront of City Centre under P.S. Matigara, Siliguri Police Commissionerate.

In this regard I ASI Prabir Karmakar, presently posted to Uttarayan Out Post under Matigara P.S. beg to submit that on the night of 19/20-09-2025 while myself along with C/604 A. Ojha, CV/967 Jimmi Roy and CV/602 Ratan Barman were performing Night Patrol duty at City Center, P.S.- Matigara vide C.C. No. 21(09)25 and Uttarayan O.P. GDE No. 330, Dated 19/09/2025. At about 02:20 hrs we found that some people were creating chaos/quarrel infront of City Centre amongst themselves. As such we went there and asked them the reason of such chaos/quarrel and tried to pacify the situation but they became furious and started scuffling with us also challenged our authority. We tried hard to manage the situation under control but they suddenly attacked upon us, started assaulting us with fist & blows, kicks as well as with bolder (stone). As a result my assisting force viz CV/967 Jimmi Roy sustained grievous injuries over his head and CV/602 Ratan Barman sustained severe bleeding injuries over his face and other parts of their body. However with the help of Security personal of City Centre we could apprehend above noted 04 (four) accused person where remaining 2/3 managed to flee away. Finding no other alternatives I arrested above noted 04 (four) accused persons u/s 35 of BNSS from the spot and took into custody.
