I Gulshan Begam (Mob:78669-06785) wife of Samser Ali, resident of Gurung Basti, Near- Durga Mandir, Ward No. III of S.M.C., P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling, would like to inform you the following facts:-

1. That ^{Yesterday} ~~to-day~~ at about 5.00 P.M. to 5.30 P.M. (evening) some persons namely (i) Md. Ramjani @ Md. Abdul son of Noor Hassan, (ii) Shahjahan Khatun @ Putul Khatun wife of Noor Hassan and (iii) Khusboo Khatun wife of Md. Ramjani and 3 to 4 their associates all are resident of Dharam Nagar Coolipara, ward No. I S.M.C., P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, came to my house and create nuisance by saying unparliamentary words without any reason after that I raised objection to stop nuisance then they physically assaulted and brutally attacked me and my younger daughter in-law namely Muskan Begam with fists and blows.

During such operation, they theft Rs.5,000/- kept on the table from my house.

2. That my said younger daughter in-law namely Muskan Begam got serious injury on her lower abdomen, head, legs, and whole body swelling, now she got very serious injury on her person.
3. That due to such assault upon me and my aforesaid younger daughter in-law and due to their such attempt to murder in such cruel manners, my said younger daughter in-law sustained severe injuries on our person, and I and my said younger daughter in-law we were medically treated at Siliguri District Hospital, Siliguri, Dist. Darjeeling ^{Yesterday} ~~today~~ at about 8.15 P.M.

and still we are under medical treatment.

4. That due to serious injury caused due to such assaulted by them upon my aforesaid son and me delay is caused for lodging this F.I.R. which may kindly be condoned.
5. That the Xerox copies of medical treatment papers are enclosed here with for your kind perusal.

I therefore request you to kindly take necessary steps against the aforesaid culprits for the commission of the aforesaid offences upon my aforesaid daughter in law and me.
