Dear Sir,

I Sri Suryansh Agarwal , son of Sri Ajit Kumar Agarwal and one of the Partners of M/s Astha Medical carrying a business of medicine retail outlet with its several branches at Siliguri an adjoining area having its registered office at Park Palace , Hill Cart Road , Siliguri Post Office and Police Station Siliguri District Darjeeling do hereby inform you as follows :-

1. That I had gone for medicine purchase at wholesale market at Khudirampally in the shop of M/s Ess Pee Gee Enterprise at Khudirampally , Siliguri around 2.20 P.M
2. That the Owner Sri Amit Jain refused to take my order as our entire counters are selling medicines at a discounted price.
3. That on asking him to give in writing the same as the orders were urgent he slapped me first. I took out my mobile and started recording his action in which I was pleading him and he got more furious and he took the scissors in his hand and took hold of my collar to stab me. In the meantime Sri Subrata Ghosh , Bankim Chandra Choudhury accompanied him and dragged me to some unknown room with an intention to murder me.
4. That in the meantime they snatched my mobile and my chain too.
5. This incident occurred today.
