With due respect I Moumita Majumdar Roy w/o Soumyajit roy d/o Mriganka Sekhar Majumder, aged 28 years residing at Purba chayan para, Dabgram-II, Block -Rajgang, P.O. – Ghugumali, P.s.- Bhaktinagar, Pin – 734006, like to draw your kind attention on the following effect that I got married on 10/07/2017 under Hindu rites and customs in presence of both family members and at the time of marriage my father fulfilled entire needs as per their demand. Approximately 50 grams gold ornaments, verious furniture etc they took as dowry. And due to our wedlock one male child was born on 23/4/2019; namely Rishav Roy. But soon after my marriage the above mentioned accused persons tortured me physically and mentally, not only that after marriage they demanded hugh money from my father and he gives my husband approximately Rs. 3,00,000(three lakh rupees)in cash part by part but they again and again demanded more money and at and when I refused to do so, they increase their torture level. Most of the time they did not provide proper food to me not only that my husband always doubted upon my character and always using filthy languages upon me and when I defend him, he beat me very badly, I bear everything by thinking that one day everything will be alright but they never change their activities. I also mentioned here that my sister in law i.e. the accused no -3 after marriage most of the time stay in my in laws house and always tenting upon me with the help of accused no -4 i.e. her husband. One day when I talked with my father my husband came with dare consequences and told me not to keep relation with my parental house and when I refused to do so then they deserted me from their house and at the time of leaving they forcefully took my signature on a paper in which I don't know what was written and keep my son on their custody finding no other alternative way I went to my parents house and after that I called my husband several time

to take me in my in laws home but he refused and most of the time he did not picked my call not even that they did not allow my son to talk with me.

Then being a helpless mother today morning at about 11.30 a.m. I went to my matrimonial house to bring my son but when I entered my bedroom my husband along with my mother in law pushed me and kick me here and there as result I sustain grievous injury on my body and head then some how I fled away along with my son from their house and my father took me to the district hospital and there my treatment is going on.

Therefore I request you please look into this matter as soon as possible and take proper legal action against this illegal activities and give relief to me.
