

Sir,

I, Sri Debanjan Datta, S/O-Sri Ramendra Nath Datta, age 30 years, posted as Assistant Engineer (E) at Siliguri Town Division, WBSEDCL would like to inform you that on 18.09.2025 early morning an accident occurred where above said vehicle collided with a WBSEDCL 9M HTOH PCC Pole at Naresh More near Gas Godown by which 11 kV Naresh More Feeder of Rabindranagar 33/11 kV S/Stn of WBSEDCL is passing.


Due to this accident both HT & LTOH infrastructure of WBSEDCL have been damaged, leaving the said area in no power condition until restoration is completed. On account of this accident, WBSEDCL has to bear a total cost of Rs. 1,34,520/- approximately as network restoration charges.

Therefore, you are requested to lodge the complaint & take necessary action against the miscreant accordingly.
