This is to inform you that I **Smt. Sudipta Bhattacharjee**, wife of Sri Sukhendu Bhattacharjee, resident of Jagadish Chandra Bhattacharjee Sarani, Hakimpara, P.O. & P.S. Siliguri, Dist. Darjeeling, Pin no. 734001, Within the state of West Bengal am the absolute owner of the land measuring 38 Decimals or 0.38 Acre, recorded in L.R. Plot No. 212, 213 corresponding to the R.S. Plot No. 39, R.S. Khatian No. 46 corresponding to the L.R. Khatian No. 666 (Previous L.R. Khatian Nos. 567, 568, 572, 578, 580 and 58), Mouza- Mantadari, Sheet No. 04, J.L. No. 06, Pargana – Baikunthapur, under Mantadari Gram Panchayat, P.O. Mantadari, P.S. Bhorer Alo, Dist. Jalpaiguri, Pin No. 735135, West Bengal as described in the schedule below purchased on 25/08/2022 by virtue of a registered deed of Conveyance being No. 08029 for the year 2022, registered at the office of the A.D.S.R. Bhaktinagar, Dist. Jalpaiguri.

That after purchase my below schedule land I had recorded my name in the R.O.R. (Record-of-Right) being L.R. Khatian No. 666, L.R. Plot Nos. 212 and 213, Mouza- Mantadari, Sheet No. 4, J.L. No. 6, P.S. Bhorer Alo (Previous P.S. Rajganj), Dist. Jalpaiguri, for the land measuring 38 Decimals.

That since the date of purchase I have been holding, enjoying and possessing my below schedule land free from all encumbrances and without any disturbance and I already installed my name's signboard in my below schedule land and I had also constructed one tin shaded temporary structure over my schedule land and I also continuing construction the tin shed temporary structure over my below schedule land.

That on 17/09/2025 I came to know that some hooligans under the guidance by the Kamti Education Foundation along with Mantu Boro had demolished my tin shed structure illegally on 17/09/2025 at about 1:00 a.m. as described in below schedule land.
