With reference to the captioned subject, I have been directed by the Superintendent of Post Offices, Darjeeling Division, Darjeeling vide letter no. CAT/A/2031/2021 dated 22.05.2025 to lodge FIR against Shri Uttam Mandal, the then Gramin Dak Sevak Branch Postmaster (GDSBPM), Ranidanga Branch Post Office (Now dismissed from Service) for getting appointment on the basis of forged Madhyamik Pariksha marksheet.

Shri Uttam Mandal S/o Shri Banamali Mandal was appointment provisionally on the basis of marks obtained in the Madhyamik Pariksha examination 2001 but during verification, the Marksheet was found to be forged as intimated by the Regional Officer, North Bengal Regional Office, W.B. Board of Secondary Education vide letter no. NB/VC/301/A/2021 dated 02.11.2021 and no. NB/VC/368/2022 dated 27.01.2022.

I, Bhim Bahadur Chhetry S/O Late K. B. Chhetry working in the capacity of the Assistant Superintendent of Posts, Siliguri Sub-Division would like to lodge FIR against Shri Uttam Mandal with your PS.
