Budhdev Singh Gupta, my son namely, (3) Rahul Gupta @ Sonu (4) Rajat Gupta @ Baby D/O Sri Manoj Gupta, all were near Sulewa Mandir Santosh Nagar, Ward No. 5, P.S. Soligudi, along with our relative namely (5) Ankit Gupta s/o Sri Rajen Gupta of Near Santosh Mandir, Santosh Nagar, Ward No. 5 SMC, P.O. P.S. Soligudi, Distt.
