I Santosh Prasad, the above noted Complainant, beg to inform you that, on 20.07.2025 at about 08:30 pm to 09:20 pm, at Night, the above noted alleged persons entered into our house at Santosh Nagar and started abusing me and my family members namely (1) fullkumari s/o Sri Santosh Prasad (2) Sangita s/o Sri Suresh Prasad and my brother namely (3) Suresh Prasad (43) d/o Lt. Chandra Prasad and when we all protested, they started beating us with belt and punch brutally and thereafter they took out vegetable cutting knives and attacked on us, I and my brother namely Suresh Prasad received severe injury on our person because their intention was to kill us.

Me & my brother namely Suresh Prasad, immediately shifted to Siliguri Distt. Hospital & treated ourselves there.

The above noted alleged persons are of very desperate & dangerous in nature and they have threatened us to kill.

So, please take necessary action against above noted alleged persons.
