In producing herewith three (03) arrested accused persons, namely (i) Dhaneswar Roy @ Sir. Karna (27 yrs) s/o- Kartick Roy of Sareohati 182, Shoulamari Ranirhat, Dakshin Alokjhari, PO+PS- Meteliganj, dist- CoochBihar, A/P- Bholanathpara, PO- Goghomali, PS-Bhaktinagar, dist- Jalpaiguri (ii) Bikram Deb Adhikary (26 yrs) s/o Manik Adhikary of Ashighar More Purba Chayanpara, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri and (iii) Sourav Saha @ Deep (19 yrs) s/o- Lt. Maheshwar Saha of Niranjannagar, Chika More, ward no.-36, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri arrested u/s- 35 BNSS along with following seized articles viz:

(1) One 20 mm iron-made rod measuring two feet (approx.) was found in the possession

of Bikram Adhikary, which was kept in his left hand.

(2) One iron-made crowbar measuring approximately 15 inches (approx) with a plastic butt was found in the possession of Dhaneswar Roy @ Karna, which was kept in his right

(3) One iron-made screwdriver with a plastic butt measuring six inches (approx.) was

found in the possession of Sourav Saha @ Deep, which was kept in his left hand.

I, ASI Tapan Roy, S/O- Lt. Fanindranath Roy of Ashighar OP under Bhaktinagar Police Station, Siliguri Police Commissionerate, do hereby lodge this complaint against the abovenoted accused persons, namely (i) Sourav Saha @ Deep, (ii) Dhaneswar Roy @ Karna and (iii) Bikram Deb Adhikary and others to the effect that today on 21/09/2025 at 00:05 hrs while performing night patrolling duty received source information that 12/14 youths have assembled at Tileshwari School Ground under Bhaktinagar PS with a view to commit dacoity in a house at Ektiashal area. Accordingly, the fact was diarised in GD vide Ashighar OP GDE No- 628 dated 21/09/2025. Subsequently, after sharing the information with my superior and as per his direction, I, along with SI, Pratap Basak, SI- Agen Lepcha, C/970 Bikash Roy, C/1547 Prabir Das, C/ 134 Ginen Basumata, HG/1151 Madan Roy, CV/603 Arun Roy, all of Ashighar Out Post, left for Tileshwari School to verify the veracity of the source information. At about 00:15 hrs after reaching near Tileshwari School under PS- Bhaktinagar, I met my source and, being pointed by the source, we started walking towards Tileshwari School ground. At around 00:20 hours, we reached at Tileshawri School ground and began to cordon off the suspected individuals identified by my source. We had a strong reason to believe that they were preparing to commit a cognizable offence and were about to leave the area. However, upon noticing the police approaching, they attempted to flee. After a hot chase, we successfully apprehended three accused individuals along with the seized articles mentioned above. Unfortunately, a number of others managed to escape from the spot, taking advantage of the darkness.

During the interrogation, the apprehended individuals admitted that they had gathered there with the intent to commit dacoity at a house in the Ektiashal area under the Bhaktinagar police station.

I thereafter seized the above-noted weapons under the proper seizure list and videography, duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made between 00:28 hrs to 00:36 hrs. Following that, I arrested the above-noted accused persons u/s 35 BNSS under a proper memo of arrests duly signed by the accused persons and also supplied a copy of the memo of arrest to them.

Subsequently, I brought the arrested accused persons along with seized articles to Bhaktinagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they had gathered there to commit

dacoity in a house in Ektiashal area.

Hence, under the above noted facts and circumstances a specific case may kindly be started under proper section of Law against the above noted arrested accused persons viz (i) Dhaneshwar Roy @ Karna (26 yrs) s/o- Karthick Roy of Bholanathpara, PO- Goghomali, PS-Bhaktinagar, dist- Jalpaiguri [not verified] (ii) Bikram Deb Adhiklary (26 yrs) s/o Manik Adhikary of Ashighar More Purba Chayanpara, PO- Goghomali, PS- Bhaktinagar, dist-Jalpaiguri [not verified] and (iii) Sourav Saha @ Deep (19 yrs) s/o- Lt. Maheshwar Saha of Niranjannagar, Chika More, ward no.-36, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri and others and arrange for its investigation.
