Sir,

In producing herewith two (02) arrested accused persons namely (1) Aman Shekh (M/18) s/o Alfajuddin Shekh of vill +P.O - Sahajpur, School More, P.S Kaliachak, Dist. Malda (not verified) and (2) Md. Hamidur Rahaman @ Hamidur Rahaman (M/40) s/o Majiruddin Shekh of vill+P.O- Baliadanga, Near Mahila Madarsha, P.S Kaliachak, Dist. Malda (not verified) along with the following seized articles, as per seizure list viz:

1. One (01) Transparent Zipper Plastic Pouch containing Two Hundred and Seventy Three Grams (273 grams) said to be Brown Sugar marked as "Exhibit - A".
2. One (01) Transparent Zipper Plastic Pouch containing Two Hundred and Seventy Three Grams (273 grams) said to be Brown Sugar marked as "Exhibit - B".
3. One yellow/green printed plastic carry bag, printed "COSMO BAZAAR. FAMILY SHOPPING" on it marked as "Exhibit - C".
4. One black color backpack printed "TOMMY AMIT HILBGER" on it marked as "Exhibit-D".
5. One red color mobile of Motorola G-85 model having IMEI-1- 350794157472675116. IMEI-2- 350794157472683116 containing SIM- 9749566874.
6. One pale blue color Mobile of POCO brand having IMEI-1- 868331070009501 & IMEI-2- 868331070009519, containing SIM- 7029456126.

In this regard I, SI Sailesh Subba of Bhorer Alo Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint against the above noted accused persons to the effect that today on 20.09.2025 at about 12.30 hours, a credible source information was received that two person possessing huge quantity of Narcotic Drugs is coming at Canal More under Bhorer Alo P.S from Siliguri Side for selling the same to his designed customers at Ambari area under Bhorer Alo P.S.

The information received was diarized in General Diary vide Bhorer Alo PS GDE No. 802, dated 20.09.2025 and informed to Officer-in-charge of Bhorer Alo PS/SPC in writing and seek his permission to work out the information. At around 12.35 hours as per kind instruction of Officer In-charge I, along with SI Biswajit Sarkar, ASI Utpal Das, Constable-505 Tapash Dutta, NVF-130 Dhanadeb Roy all of Bhorer Alo PS left to work out the source information towards Canal More under Bhorer Alo PS by Government vehicle vide GDE NO 803, dated 20.09.2025 and MCC No 90/2025, Dated 20.09.2025 to verify the veracity of the information.

During the time of departure from office, I took envelope, white paper, sealing wax, gum, seal, digital weighing machine (Certified by the weight and Metallurgy department) and other investigation kits as it would be needed if any narcotic substances were found. I, also requested videographer namely Mubarak Md. s/o Akhirul Md. of Ambari Station Road, P.O Kamarvita, P.S Bhorer Alo, Dist. Jalpaiguri in written with a request to come to Canal More with his video camera for recording the entire process of search and seizure if required. On the way towards Canal More I communicated with ASI Sarath Thapa, Mobile van officer and requested him to accompany with us for conducting raid.

At around 12:45 hours, I along with the accompanied Police team, Mobile Van and videographer reached at Canal More, Baniapara under Bhorer Alo PS, and parked the Vehicle at a considerable distance in concealed position. I then called two independent witnesses
