Both of us sustained injuries and were deeply shocked and frightened by with further harm if we reported the matter to the authorities.

I therefore request you to kindly register this complaint as on, FIR, and take strict legal action against the accused ~~and~~ under the relevant sections of the INDIAN penal code.

this incident has left us physically injured and emotionally disturbed. We are in fear of our safety. we have medical reports and any other assistance required during the investigation.
