Subject: FIR regarding physical assault on me (Caretaker/Manager of Milestone Building) by employees of HDB Financial Services

Respected Sir,

I Mr. Hrishikesh Barman, son of Tejendranath Barman resident of Naboni, Dakshin Kharija, Gitaldaha, Cooch Behar, presently residing at Jyoti Nagar, near Terai Blood Bank, am writing to you to lodge a serious complaint regarding a shocking incident of assault that occurred on 20th September 2025 at around 5.30 pm at the Milestone Building, 2nd Mile Check Post, Siliguri.

On the said date, certain employees of HDB Financial Services, who operate their office in the Milestone Building, physically attacked, manhandled, and assaulted me, caretaker/Manager of the building. I just told them not to do smoking inside the building premises. The individuals involved, including managers and officials of HDB Financial Services, also called people from outside to create a mob that physically abused me. This brazen act of violence inside the premises has not only endangered the life and safety of me fatally but has also created an environment of intimidation, fear, and insecurity for all shop owners, tenants, and occupants of the building.

Such lawless and violent behaviour by employees of a corporate entity is completely unacceptable and cannot be tolerated under any circumstances. I therefore demand that an FIR be immediately registered against the employees involved, and that a full and fair investigation be conducted without delay. The guilty individuals must face the strictest legal consequences as prescribed under law.

I am also enclosing CCTV footage of the incident as evidence, which clearly establishes the unlawful actions of the accused.

In light of this grave incident, I further demand police protection for the Milestone Building to ensure that such criminal acts are not repeated and that the safety and security of all persons connected with the premises are guaranteed.

I urge you to treat this matter with the highest priority and seriousness, and to initiate immediate and firm action so that justice is delivered at the earliest.
