Subject $\Rightarrow$ Complaint against men for assault, abuse and threat to murder, acid attack.

Respected Sir / Madam,

I Haushita Gupta resident of Durganagar Sikkon mandir road wish to lodge the information report regarding a violent incident that took place on 20/9/2025 at around 10PM 2.30 AM near durganagar

on that night, a group of drunk men, who were in drunken condition, physically assaulted me and my family even all my guest who was invited in my house for dinner. They beat us badly used obscene and abusive languages and gave us threat to kill each one of us and acid attack. Their violent and aggressive behaviour created fear and panic among the people present.

Details of the incident:-

I was having normal conversation over a phone call my dog came out and started playing with other dogs then our neighbour he beat with stick then I said uncle don't do he will bite you, then uncle pressure started then aunti came and said go inside then I came

inside my home; then all the boys come and started shouting the come outside you all don't leave the home right now, we all 4 girls my father is no more. Then they were drunk started using abusive languages and created a panic moment. And the twins brother he gave me slap on my mother and pushed me I fell ~~down~~ down. Then in my defence I also slapped back to him. The 10-15 boys started beating me, then my family members came out of the home and saved me. Even they have given us death threat.

I request you to kindly register an FIR under the section section 323 IPC, section 354 IPC, section 294 IPC, section 506 IPC, section 509 IPC, section 34 IPC, investigate the matter urgently and take strict action against the culprits to ensure justice and safety.
