Sub: Complaint regarding misappropriation of goods by transporter/driver

Sir,

I, Anil Agarwal, son of Late Indarchand Agarwal, Partner of Northeast Builders, a partnership firm, most respectfully submit that.On 13.09.2025, I received an order from B.R. Enterprise, Nimtala, PS − Posta Police Station, Kolkata, to supply colour tin sheets. Pursuant thereto, I raised Invoice No. NEB/25-26/001254 dated 13.09.2025, for a total value of □29,48,800/- and made the consignment ready for dispatch from my godown situated at Eastern Bypass, Baneswar More, PS − Ashigarh Outpost. On the same day, I entrusted the said goods to one M/S Bablu Tiwari, Transport Contractor, having his office at Tumba Jote, P.O. & P.S. Matigara, District Darjeeling, under Consignment Note No. SLG-133, for delivery of the goods to B.R. Enterprise at Kolkata.

The said consignment/goods was loaded in a truck bearing Registration No. WB-25-L-2677, driven by one Anwar Ansari, son of Kasim Ansari, resident of 244, G.T. Road, Liliah, Howrah – 711204, having contact no. 6291588792. The owner of the vehicle is one Dinesh Shaw, son of Ramdhani Shaw, residing at Andul Road, Panchpara, Nimtala Mouri Gram, Radhasi, District Howrah, having contact no. 97340-72465. The goods were supposed to reach the consignee's destination by 17.09.2025.

However, when the delivery did not take place within the stipulated time, I contacted the transporter, who informed me that on 17.09.2025 at around midnight the driver had spoken to him and stated that due to Vishwakarma Puja he was unable to deliver the goods on time but assured that the same would be delivered by 19.09.2025. Again, on 19.09.2025, the driver informed the transporter that he had already crossed Jaladhulagori (Dhulagarh) Toll Plaza on

NH-6 and promised to deliver the goods the very same day. However, despite such repeated assurances, the consignment never reached its destination.

Subsequently, repeated attempts were made to contact both the driver and the owner of the said vehicle, but their mobile phones were found switched off and no communication could be established. On further enquiry from the transporter, I later came to know that the said driver had dishonestly disposed of the entire consignment and misappropriated goods worth nearly  $\Box 29,48,000/-$ , by illegally selling the same to unknown persons.

In the above circumstances, I humbly request you to kindly register my complaint, investigate the matter and take appropriate legal action against the driver, the vehicle owner and all other persons involved for committing fraud, criminal breach of trust and misappropriation of goods belonging to my firm. I am also enclosing a copy of the invoice; consignment note and other relevant documents for your perusal.
