I, Soni Oraon Oran president of  
Moharagaon Anulma Tea Estate p.s. pradhan nagar west  
Bengal Dist Darjeeling would like to lodge this  
complaint against Appu Siddik s/o Abdul Majid  
of new Basti, Salbari to the effect that I got  
intimate relation with Appu Siddik about 3 years  
ago and we used to get together and planned  
for marriage. In the meantime he was arrested  
for illegal acts and was in jail for about 11 months.  
After that I came to know about his acts and  
that he is a drug addict and I deseperated myself.  
After release from jail about a month ago he suddenly  
appeared in my house and forcefully started  
living with me for the last 1 month he lived  
on my earnings. I have to give him money for his  
enjoyment with friends, for his drug else he  
brutally assulted me. I tried to avoid him but  
he started threatening me every where to kill me  
and my son, he drove my son prakash for  
patna (9) from my home and to save my son  
life I kept my son in my parental house. He  
captured some intimate moments pictures of mine  
and threatens to upload it in social media.
