Sir,

I, Debjani Das, Wife of Surojit Sen, aged 25, resident of Road No. 6 of Shaktigarh, near Noori Masjid, P.O. – Siliguri Bazar, P.S. – N.J.P., District – Jalpaiguri, last evening, i.e., on 20/09/2025 at about 6.30 P.M when was returning home after doing some marketing with my sister-in-law, one Suku Roy son of Nripen Roy, resident of Road No. 11 of Shaktigarh, P.O. – Siliguri Bazar, P.S. – N.J.P., District – Jalpaiguri who is from the same locality stopped me near rail line of Mahabirsthan and asked to have a talk with him. When I refused being aware of his bad reputation and character he became adamant and started pulling me by grabbing my upper arm and my sharee. When I resisted he molested me. However with the help of my Sister-in-law (my husband's brother's wife) I pushed him and saved myself. As others also noticed the incident Suku Roy fled away from the spot.

From last night I am in trauma and in panic that he may again try to repeat the above incident as I have heard that one attempt to murder and one rape case are pending against that Suku Roy.

Under the circumstances, I request you to kindly treat this written complaint as FIR, initiate a case against the above mentioned Suku Roy, arrest him and take legal action against him.
