Sub: - Letter of Complaint against Md. Mustak (19 Yrs) S/O Taimur Rohaman of Shantipara, PO- Bhaktinagar, PS- New Jalpaiguri, Dist- Jalpaiguri for illegal storing of Domestic Gas Cylinder at his rented shop.

Sir,

In producing herewith the following seized articles with original seizure list, viz:-

(i) Total Twenty four (24) numbers of Indane Domestic Gas Cylinder fully empty.

I Inspector Prosenjit Das of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge the written complaint against accused person namely Md. Mustak (19 Yrs) S/O Taimur Rohaman of Shantipara, PO- Bhaktinagar, PS- New Jalpaiguri, Dist- Jalpaiguri to the effect that on 20/09/2025 at about 12:45 Hrs hrs received a secret source information that one Md. Mustak (19 Yrs) S/O Taimur Rohaman is illegally storing and selling Domestic LPG and Commercial cylinders i.e. Indane at his rented shop for the purpose of selling in open market without any valid license or documents for his wrongful gain. Hence I diarized the matter vide EB, SPC GDE No. 94 Dt. 20.09.25 and informed the matter to ACP EB, SPC and as per his instruction myself along with SI Raju Sarkar, ASI Arghya Das, L/C 1270 Deeptina Gazmer all of EB, SPC left EB Office to proceed Ambikanagar, Chatpukur, PS- New Jalpaiguri, Dist- Jalpaiguri to execute the information. This refers EB, SPC GDE No.95 Dt. 20.09 .25.

At about 13:25 hrs we reached at Ambikanagar, Chatpukur, PS- New Jalpaiguri, Dist- Jalpaiguri and contacted with source and being shown and identified by him, I along with officers and force conducted raid in the rented house of Md. Mustak and found that the above noted accused person is storing and selling loaded LPG cylinders i.e. Indane. On searching, the above noted seized articles have been recovered from his shop. On being asked the above noted accused person failed to produce any valid documents in support of above noted seized articles.

It is crystal clear that the said person namely Md. Mustak (19 Yrs) S/O Taimur Rohaman of Shantipara, PO- Bhaktinagar, PS- New Jalpaiguri, Dist- Jalpaiguri is storing and selling the Domestic cylinders at his rented shop for his wrongful gain. As per local enquiry it came to light that the above noted person storing and selling gas negligently with respect to fire or combustible matter, which may endanger human life or likely to cause hurt or injury to person at that locality area. Md. Mustak does not have any valid License/ Permit of dealing /distribution / selling and storing LPG. Thus the above noted accused person violated the provision of West Bengal Cooking Gas (License and Control) order 1985 and other Government Orders.

Accordingly I seized the above noted seized articles as per seizure list in presence of local witnesses namely 1) Md. Sameer Ali (18yrs) S/O Md. Sabeer Ali of Haripur Gawalapatty PS- NJP, Dist- Jalpaiguri and 2) Chattu Yadav (25yrs) S/O Samir Yadav of Haripur Gawalapatty, PS- NJP, Dist- Jalpaiguri . The seizure was made in between 13:35 hrs to 13:55 hrs.

Hence, I pray that a specific case may be recorded against the accused person namely Md. Mustak (19 Yrs) S/O Taimur Rohaman of Shantipara, PO- Bhaktinagar, PS- New Jalpaiguri, Dist- Jalpaiguri U/S 287/3(5) BNS R/W Sec 7(1)(a)(b)(c) of EC Act 1955 and other appropriate sections of law.
