would like to draw your attention towards

s/o - Lt. not known ③ Vikash Jha @ Channa
s/o - not known ④ Binjan Gupta s/o - not known all
residents of Ganga Nagar road no. 5 and his
10 associates forcefully stopped me.

- ② That when I asked them to why they
stopped me all of sudden virek Singh
and Vijay Sahani started assaulting me
with iron rod and fist on blow on my
face.

- ⑥ That me and my friend were saved both of us from all of them and ran away from the spot and save ourself.

(7) That it is pertinent to mention here that the Virek Singh, Vijay Sahani, and Vikash Gha @ Chhann all are very famous Criminal of this area and history sheeter in different Criminal Cases which are pending before the H. Court and presently Virek Singh recently taken bail from Siliguri Court in other Case.

That i on the above facts requesting you to take necessary prompt legal action against all the above named Persons and save me from them as they threaten me to kill me anytime.
