Respected Sir/Madam,

I, Shivani Subba, resident of Maruti Residency, Bandrojote, Nagapur am writing to formally bring to your kind attention a matter of serious concern regarding a road accident that occurred on 11th September 2025 at approximately 10:40 a.m. on Seroke Road.

On the mentioned date and time, a Venue car bearing Registration No. WB74 BQ 1300, driven by Mr. Aman Agarwal, hit me and my 68 year old mother. As a result of this accident, both of us sustained injuries and my mother had to be immediately admitted to Dr. Nayak Nursing Home for emergency treatment.

It is also pertinent to mention that, due to the severity of her injuries, my mother had to be admitted again to Pulse Hospital under the care of Dr. Parag Kumar Agarwal, Consultant Neurosurgeon and was kept under medical surveillance from 12th to 14th September 2025.

Presently my mother is still under medication for the injuries sustained on that dooful day of

September. I too have sustained injuries on my left foot and was asked by Dr. M. Bhandari, (Consultant Orthopaedic) for 2 weeks of bed rest. Hence the delay for filing this report.

I humbly request your good office to intervene in the matter and take necessary steps to ensure that the accused Mr. Aman Agarwal, is held accountable.
