crashed into us causing severe injury
to both me and my father. My father was
taken bagdogra hospital and i also got a
stich in my chin. Later we took our father
to Neotia hospital and his treatment is still
going on. He also call's me the person who
crashed into me from various number and
says me to close the case and threatens
me. Due to father's treatment the complaint got
delayed.
