In producing herewith the accused person named Rohit Sinha, aged 22 years, s/o- Sanjib Sinha, resident of Kolkata Road, Bhujiapani, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles under proper seizure list:

1. Eight (08) bottles of KINGFISHER Imperial Strong Beer, each contains 650 ml @ Rs. 160/- and marked as Exhibit- A; out of which 01 bottle is taken out as sample and marked as Exhibit- A1.

 Eight (08) bottles of "Himalayan Gold 60° UP India Made Liquor", each contains 600 ml @ Rs. 160/- and marked as Exhibit-B; out of which 01 bottle is taken out as sample and marked as Exhibit-B1.

(Total 10 ltrs, total value Rs. 2560/-)

I, SI Binup Mahato of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person named Rohit Sinha, aged 22 years, s/o- Sanjib Sinha, resident of Kolkata Road, Bhujiapani, PS- Bagdogra, Dist- Darjeeling (staff) and the absconding accused Suraj Biswakarma (shop owner) to the effect that on 20.09.2025 at 20:35 hrs received reliable source information that a huge quantity of liquor is stored at the shop of one suspect named Suraj Biswakarma located at Lalit Nagar under Bagdogra PS and the same has been selling illegally from that shop for his wrongful gain. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction of O/C Bagdogra PS, I along with ASI Amit Lama, C/1509 Sourav Roy Sarkar, VP/01 Anselam Kujur, VP/02 Pradip Roy & CV/386 Kishor Ranjan Howladar left for Lalit Nagar under Bagdogra PS, SPC to work out the secret source information. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences as well as for the escape of the offender. The matter is diarised in GD vide Bagdogra PS GDE No. 918 dated 20.09.2025. At around 20:50 hrs we reached at Lalit Nagar and being indication & identification by source we held raid at the shop of the suspect Suraj Biswakarma and managed to apprehend one staff with the help of accompanying Police personnel and interrogated him. The staff had been selling liquor to customers from that shop. On interrogation, he revealed his identity as Rohit Sinha, aged 22 years, s/o- Sanjib Sinha, resident of Kolkata Road, Bhujiapani, PS Bagdogra, Dist-Darjeeling and introduced himself as the staff of that shop. We disclosed our identity to him and the input we had. We contacted with the local people to be present as witness during the process of search, seizure, if any. But none agreed to be present there as independent witness. Then, we searched the shop in presence of the Police personnel. On search, the above noted liquor was recovered from that shop. On demand, he failed to produce any valid document/license for stocking, possessing & selling that liquor. He confessed that he with the help of his owner Suraj Biswakarma had been stocking, possessing & selling liquor illegally from that shop since long time for their wrongful gain. He stated that Suraj Biswakarma is the owner of that shop and he found absconding. Their involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) from the possession of the staff Rohit Sinha under proper seizure list and at last, I arrested the involved accused Rohit Sinha (as noted above) after observing all legal formalities and communicating him the ground of arrest in writing as he has committed a cognizable offence in presence of Police for stocking, possessing & selling that liquor illegally and issued memo of arrest in this regard. The process of search & seizure & was made in between 20:55 hrs and 21:05 hrs on 20.09.2025 through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person named Rohit Sinha, aged 22 years, s/o- Sanjib Sinha, resident of Kolkata Road, Bhujiapani, PS- Bagdogra, Dist- Darjeeling (staff) and the absconding accused Suraj Biswakarma (shop owner) and arrange for its investigation.
