In producing herewith the accused person named Surendar Tirkey @ Kaley, aged 34 years, s/o-Posha Tirkey, resident of Bhuttabari, PS- Bagdogra, Dist- Darjeeling (Aadhar No. 5198 6020 1297) under custody along with following seized articles under proper seizure list:

1. Forteen (14) bottles of "Himalayan Gold 60° UP India Made Liquor", each contains 600 ml @ Rs. 160/-; out of which 01 bottle is taken out as sample and marked as Exhibit- A.

2. Five (05) ltrs of Chullu in one green colour plastic jar of five liters; out of which one (01) liter is taken out as sample and marked as Exhibit-B.

3. Five (05) ltrs of Chullu in one yellow colour plastic jar of five liters; out of which one (01) liter is taken out as sample and marked as Exhibit- C.

(Total 18.4 ltrs, total value Rs. 2240/-)

I, ASI Munna Ahmed of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person named Surendar Tirkey @ Kaley, aged 34 years, s/o-Posha Tirkey, resident of Bhuttabari, PS- Bagdogra, Dist- Darjeeling to the effect that on 22.09.2025 at 20:25 hrs received reliable source information that a huge quantity of liquor is stored at the shop styled as "Jey Kali Dhaba" of one suspect named Kaley located at Bhuttabari beside NH-27 near Suman Hotel under Bagdogra PS and the same has been selling illegally from that shop for his wrongful gain. Accordingly, I informed the matter to O/C Bagdogra PS and as per direction of O/C Bagdogra PS, I along with SI Binup Mahato, C/1509 Sourav Roy Sarkar, VP/01 Anselam Kujur, VP/02 Pradip Roy & CV/386 Kishor Ranjan Howladar left for Bhuttabari beside NH-27 near Suman Hotel under Bagdogra PS, SPC by Govt. vehicle No. WB61A/0137 to work out the secret source information. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences as well as of the escape of the offender. The matter is diarised in GD vide Bagdogra PS GDE No. 1009 dated 22.09.2025. At around 22:35 hrs we reached at Bhuttabari beside NH-27 near Suman Hotel and made an ambush there keeping our Govt. vehicle away from the place and had been waited there for source indication. After a while, the source indicated us and being indication & identification by source we held raid at the shop of the suspect Kaley and managed to apprehend him with the help of accompanying Police personnel and interrogated him. On interrogation, he revealed his identity as Surendar Tirkey @ Kaley, aged 34 years, s/o- Posha Tirkey, resident of Bhuttabari, PS- Bagdogra, Dist- Darjeeling and introduced himself as the owner of that shop. We disclosed our identity to him and the input we had. We searched for the independent witnesses to be present there as witness during the process of search, seizure, if any. But none found available to witness the process of search and seizure, if any. Then, we searched the shop in presence of the Police personnel. On search, the above noted liquor was recovered from that shop. On demand, he failed to produce any valid document/license for stocking, possessing & selling that liquor from his shop. He confessed that he had been stocking, possessing & selling liquor illegally from that shop since long time for his wrongful gain. His involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) from his possession under proper seizure list and at last, I arrested the involved accused Surendar Tirkey @ Kaley (as noted above) after observing all legal formalities and communicating him the ground of arrest in writing as he has committed a cognizable offence in presence of Police Officers for stocking, possessing & selling that liquor illegally and issued memo of arrest in this regard. The process of search, seizure & arrest is made in between 21:18 hrs and 21:30 hrs on 22.09.2025 through audio-video electronic means using Govt. mobile App 'WB E-Shakshya' vides Evidence Certficates Nos. C-1009-15349-20250922213031 and C-1009-15353-20250922214555.

Therefore, I request that a specific case under proper section of iaw may kindly be started against the involved arrested accused person named Surendar Tirkey @ Kaley, aged 34 years, s/o-Posha Tirkey, resident of Bhuttabari, PS- Bagdogra, Dist- Darjeeling (Aadhar No. 5198 6020 1297) Received on 229.25 pt 21:55 vide gar. No-10/1 and started Brydigm h. case No-377/25 et 22.9.25 NA 46 A10 Bits Act and endoxied to Asi Everenti
