Matigara, Dist.- Darjeeling 2/ **Debu.Roy**, S/o- Not known, Resident of Thiknikata, P.O. Sushrat Nagar P.S. Matigara, 3/ **Bapi Sinha**, S/o- Anugraha Sinha, resident of Medical More, & other 10 to 15 persons/goons of the above-named persons.

Respected sir,

I Shri. Bipul Saha, S/o- Late. Rebati Raman Saha, R/o- P.S. Matigara, P.O. Shusrata Nagar, Dist.- Darjeeling, at present I am one of the partner of Jiban Seba Lab which is situated at the Ground Floor of Shantiniketan Lodge at beside the NBMC&H and in front of the said lab one room is used as sitting/waiting area of patients since 5-7 years and before that aforesaid Abhijit Roy took the said shop room from me as rent In the year 2007 till 2010. (the said tenancy dated 10/07/2007 is annexed herewith) Thereafter he vacated the said shop room in the year of 2010 and since now the said shop room is use as sitting/waiting area of patients of Jiban Seba Lab by us, and we are 3 partners conjointly running and maintaining the aforesaid lab namely 1/ myself i.e., Bipul Saha 2/ Soma Saha i.e., my wife and 3/ Ashok Kundu.

It is to be noted that during the aforesaid tenancy period Sujata Roy who is wife of the Sl. No. 1 i.e., Abhijit Roy was one of our partner of Jiban Seba Lab, but aforesaid Abhijit Roy used to do all the official works/ our labs related works in the guise of his wife, but during that time aforesaid Abhijit Roy misappropriate our aforesaid Lab's account and when we aware about the same Sujata Roy retreat from the said partnership in 14/07/2011 (the photo py of the said retirement/retreat agreement from the partnership agreement is annexed herewith) and since then Abhijit Roy tries by way of various means to create hinderance to our aforesaid lab's works and brought miscreants and looted our lab's machinery & equipment took all the machinery in truck and tried to fled away but at that time police intercept the said truck and at that time one of our partner filed a case against Abhijit Roy and his men and at present the said case is pending before the Ld. JM 2nd Court at Siliguri, Vide Gr. Case No- 2326/2012 but since this Year from the month of April the aforesaid Abhijit Roy again brought his men/miscreants in front of my adjacent room of Jiban Seba Lab, which is use as sitting/waiting area of patients and create chaos there and outraged the modesty of my son's wife and threatened me to shut down Jiban Seba Lab and then we lodged two complaints with the O/C NBMC Police out post under Matigara P.S, (the said complaints are annexed herewith this written complaint). Lastly on 19/09/2025 at about 5 AM the goons of Abhijit Roy

alongwith his Advocate with some Court Papers and he also shouted that Court had ordered that the place is under our possession and the aforesaid persons forcibly tried to enter into my aforesaid shop room after breaking the shutter of the room and threw away the chairs, table of the room, during the unfortunate incident my tenant informed me about the said matter, and thereafter we rushed to the Place Of Occurrence and requested them to stop such activity/hooliganism but instead of the same they threatened me with dire consequence and at that time the **Debu Roy** grabbed my daughter in law and tried to strangulate throat of my daughter in law by her "Dupatta" to kill her and also touched her sensitive parts of her body at that time my son i.e., the husband of her tried to rescue her but at that time the person of Abhijit Roy mercilessly assaulted him and snatched one gold chain weighing approx. 20 gm and in consequence of that I informed the said matter to the P.S. and the police came there, the persons fled away from the spot, after the said incident I received a summon from the Ld. Civil Judge Sr. Division at Siliguri wherein cited an Ad- Interim Order from the Ld. Civil Judge Sr. Division at Siliguri till 31/10/2025. By misleading the court with some distorted facts and also by placing expired tenancy agreement dated 10/07/2010 Abhijit Roy obtained the abovementioned order from the concerned court not only that he also used some documents from another labs namely Genuine Lab situated nearby my aforesaid shop for misleading the court that he also convinced the Ld. Court through his Advocate that Genuine lab is situated in my shop and he also used the trade license and another papers of Genuine Lab for showing that his business is going on from my shop (the photocopy of the said vide TS. No- 107/2025 plaint is annexed herewith) It is to be noted that Jiban Seba Lab and Genuine Lab two are separate business places. Every incident is going on as per instruction of Abhijit Roy and he alongwith his persons hatched up a deep-rooted conspiracy to grab my shop room by any means.

Originally the aforesaid Abhijit Roy fraudulently obtained the said order and presently he tried to disposes me from my aforesaid shop by using the said order. That finding no other alternatives I installed CCTV in front & inside of my aforesaid shop on 22/09/2025. Today at about 11-11:30 AM Abhijit Roy had sent a group of women approx. 40 in number had gathered wherein their clothes there was a badge of Genuine Labs and had claimed that the aforesaid shop is of Abhijit Roy and tried to take forcible possession of my shop. At that time some local people had gathered there and the Police also reached there for which they had fled from the spot. This matter is so Sur searched and sensitive that at any moment a heinous crime can occur at that spot.

Aforesaid Abhijit Roy is ferocious man and he won't take time to create a scene or fight which is danger to my life.
So, in view of the above you are requested to take proper legal action against the aforesaid culprits.
