Sir,

Most respectfully, I would like to lodge this written complaint against driver of the
vehicle no. **WB74BF 9378** as follows: -

That, on 23.09.25 at around 10:20 hrs, I was going towards NBU PO in my motor
cycle bearing no **WB 74 Q 9772** to attend my office as I am posted as Postmaster,
NBU Sub- Post Office, Dist. Darjeeling through Noukaghat-Medical More Road. At
that time vehicle no. **WB74BF 9378** which was going to the same direction and was
coming from behind.

That, near North Bengal Medical college auto stand on Noukaghat-Medical More
Road the vehicle bearing no. **WB74BF 9378** dashed me from side causing damage
to my motor cycle bearing no **WB 74 Q 9772**. As a result of such act I fell down on
the road and got severely injured. Later, I called my colleagues there.

That, afterwards, I treated myself at North Bengal Medical College & Hospital.

That, due to good road condition the driver of the vehicle was driving his vehicle in
very excessive speed and also in rash & negligent manner.

I, therefore request your goodself an appropriate legal action may be initiated
against driver of vehicle no. **WB74BF 9378** for rash & negligent driving and driving
his very dangerously in excessive speed in public road.
