

The complainant above named beg to state as follows :-

1. That the complainant is law abiding and peace loving citizen of this country.
2. That the elder brother of the complainant namely Ranjan Sah has love and affection with one Smt. Priyanka Kumari Sah since 5 years and the parents of said Priyanka Kumari Sah were against the said relationship.
3. That the parents of said Priyanka Kumari Sah put tremendous pressure upon her to marry with other person and due to such pressure said Priyanka Kumari Sah and Ranjan Sah have decided to marry against the will of her parents and they have registered their marriage before the Marriage Registrar namely Pulak Bhowmick on 07.08.2025 according to Special Marriage Act.
4. That after the said registration of their marriage, said Priyanka Kumari Sah and she resides in her parental house situated at Shanti Nagar, near Binoy More, P.S. Bhaktinagar, Dist. Jalpaiguri.
5. That elapsing of few days from the date of registration of marriage, the parents of said Priyanka Kumari Sah came to know that her daughter Priyanka Kumari Sah has already registered the marriage with Ranjan Sah.
6. That after getting knowledge of the said marriage, the parents of said Priyanka Kumari Sah threatened the elder brother of the complainant namely Ranjan Sah, if he tried to contact with said Priyanka Kumari Sah he and his family will face dire consequences.
7. That thereafter said Priyanka Kumari Sah called the said elder brother of the complainant and told him that her parents are torturing her physically and mentally and she cannot stay there anymore.
8. That thereafter on 21.08.2025 said Priyanka Kumari Sah came to the house of the complainant and started residing there with the elder brother of the complainant as husband and wife.
9. That on 22.08.2025 at about 7:30 pm when the complainant going to Thana more from his shop at Kelahatty Bazaar, Siliguri for some work.

Suddenly 7-8 unknown persons stop his vehicle at Mahabirasthan, near Khadims showroom and asked his brother's name and when he told the name of his elder brother, said persons started beating him with puncher/knuckles and small knife and tried to cut his throat by the said knife and for this attack the said complainant sustained Severe injuries in his face and head and they were tried to kill the complainant.

10. That during this incident said persons snatched gold chain weighing about 9 grams of the complainant and due to the said attack complainant lost my consciousness and fall on the road.
11. That thereafter local people took me to the Siliguri District Hospital for his treatment.
12. That after inquiring at that area the said complainant came to know the names of the said miscreants who attacked him on 22.08.2025 who happens to be near relatives and family friends of the brother of said Priyanka Kumari Sah. The names are (1) Sri Raju Sah, Son of Sri Ram Kishore Sah, (2) Sri Joy Ghosh @ Mithun, (3) Smt. Nitu Sah, Daughter of Sri Ram Kishore Sah, (4) Smt. Priti Sah, Daughter of Sri Ram Kishore Sah, all are resident of Shanti Nagar, Binoy More, P.S. NJP, Dist. Jalpaiguri, (5) Sri Pratap Gupta, Son of Kishore Gupta, resident of Nayabazar, Near Gandhi Maidan, Khalpara, P.S. Siliguri, Dist. Darjeeling and some other persons.
13. That to take revenge against the elder brother and the family members of the complainant said accused persons and their men and agents mercilessly beaten up the complainant and also snatched his gold chain.
14. That thereafter on 11:45 pm on 22.08.2025 complainant alongwith his family members went to the Siliguri Police Station to lodge written complaint but duty officer told them to come in the morning as they don't have any patrolling van at that time.
15. That thereafter on 23.08.2025 at around 09:45 am complainant alongwith his elder brother went to the Siliguri Police Station to lodge the complaint and duty officer at that time in the police station took the written complaint but did not gave him any received copy of the same and the said duty officer told the complainant that they will inform him about the status of his complaint later.
16. That on 28.09.2025 complainant went to Siliguri Police Station for the receive copy of said complaint dated 23.08.2025 and duty officer told the complainant that they did not registered the complaint and also they did not have any received copy of the said complaint.
