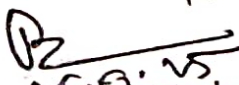
Respected Sir,

they will not give the food to us and in
that time I asked them why they abused

will go and at that time they started
passing my brother and out of no where
they started hitting us and said Deepak sharma

and his son Anwar sharma touched my private parts and even snatched my golden chain from my neck and after that I called my other brother Nitin Agarwal Mittal and informed him about the situation and he came to the spot and tried to stop them from hitting my other brother and at that time said Deepak sharma brought a rod from the kitchen and hit my brother Nitin Agarwal Mittal on his head and there was a blood flow from his forehead and seeing the situation and from the help of locals we took him to Siliguri district hospital and is admitted in hospital.

Now I it very pertinent to mention that the people who without any reason just attacked us and hit us in such a manner and even touched my private parts having no fear of law and without any social ethics have assaulted us physically and mentally, so sir I would like to request you to take strict action against this persons.
