## Sub: Written complaint

## Respected Sir/Madam,

I, SMT PARUL SHARMA, W/o Pawan Sharma, aged about 65 years, Hindu by Religion, Indian by Nationality, resident of S.P. Mukherjee Road, Khalpara, Siliguri, P.O. & P.S. Siliguri, in the district of Darjeeling do hereby state as follows:

- That I am law abiding senior citizen and I along with my family members run a kitchen cum dine-inrestaurant at S.F. Road in the name and style of Dadi's Kitchen, situated near Raja Paw Bhaji and Punjab National Bank.
- That on 24.09.2025 at around 10:00 pm one Manchica Mittal along with one kid came to our kitchen and ordered food for dine-in.

It is worthy to note here that the abovenamed Manchica Mittal is our regular customer who visits our kitchen on a daily basis.

- 3. That we usually get bulk orders of roti and sabzi and today too we had many orders to deliver at that time, even though we had bulk orders we took the order of the abovenamed Manchica Mittal as she is our regular customer and provided the same to her at time.
- 4. That after finishing her meal i.e. around 10:20pm, abovenamed Manchica Mittal asked me to pack 7 parathas for takeaway and I requested her that it would take some time to prepare her order as 1 had many orders to fulfill.
- That after my request to grant some time for preparing her order she started hurling abuses at me for delaying order and threatened me of dire consequences if I don't prepare her order first.
- 6. That she even called her brother to our kitchen who also is a regular customer in our kitchen, upon arrival he started abusing me and my family members and started throwing our table and chair and even threw his hand and fists upon my son Dipak Sharma and my grand son Aarav Sharma aged about 15 years.
- 7. That they even called many miscreants and anti-social elements from babupara and started creating a ruckus at our kitchen by even stealing money from our counter and throwing their hands and fists on my son and grandson.
- 8. That they didn't even spare my daughter-in-law Khusi Sharma and started using abusive and demeaning language towards her and even tried to throw hands on me and my daughter-in-law, but with the support of the neighbors and local people gathered, no harm on our body was made by them.
- That they threatened us of dire consequences and even threatened us that if we run our kitchen, they will burn
  our kitchen and beat us to death.
- 10. That the aforesaid persons who came along with abovenamed Manchica Mittal are local goons and they do not hesitate to take law in their own hands.
