I, ASI (UB) B41 Dhiraj Chhetri of WBP, presently posted at Jalpaiguri Traffic Guard (SMP), beg to inform you that on 24.09.2025 at about 21:20 Hrs, when I was performing my traffic duty at S.F. Road (Opp. Soliguri Fire Station), at that time a truck bearing Regd. No AS-17-B-2617, came in a rash & negligent way breaking all the cable wires where S.F. Road, and after receiving my signal to stop, the said truck was stopped and the driver of the vehicle was ready to pay required fine under the proper section of M.V. Act.

But in the meantime, suddenly a person reached there and introducing himself as the agent of some Transport service and restrained me to perform my duty and pushed me back and tried to assault me physically.
