Sub: Lodging of F.I.R

Sir,

I, Puja Roy, wife of Subhajit Sarkar, resident of 29, Shreema Sarani, Sarada Pally, Ward No. 37, S.M.C., respectfully state the following:

On 23/09/2025, between 9:00 a.m. and 9:30 a.m., while my husband was standing in front of our gate, my neighbor, Bhaskar Dutta, son of Kanai Dutta, parked his E-Rickshaw blocking our entrance. My husband requested him to kindly remove the vehicle so that we could pass through. However, the said Bhaskar Dutta suddenly started abusing us with filthy language directed at my mother-in-law and me, which cannot be spoken in a civilized society. He also stated, "I will not remove the Toto, do whatever you want."

At that point, I too requested him to remove the Toto so that we could go out for our daily work. It may be noted that the accused has habitually done this several times earlier. On being requested, he again abused me with offensive language. When my husband protested against his wrongful act, the accused struck my husband's arm and back with a wooden stick.

When I tried to rescue my husband, the accused also misbehaved with me, touched my body in an indecent manner, physically assaulted me, and attempted to outrage my modesty. My husband tried to intervene, but the accused then attempted to strangle him, due to which he almost suffocated. Somehow, my husband managed to push him away. Immediately thereafter, the accused attacked my husband's neck with a sharp weapon with the intention to kill him. My husband managed to escape but suffered a severe cut injury on his neck, which was bleeding profusely.

Hearing our screams, neighbors rushed to the spot and rescued us from the situation. Afterwards, they took us to the hospital for treatment.



It is also pertinent to mention that the accused threatened me, saying that if I step out of my house, he would ruin my life and modesty, and that he would chop my husband into pieces with a sharp weapon.

Due to the above incident, my family and I are mentally disturbed and living in constant fear of stepping out of our home. Therefore, I humbly request you to kindly take necessary legal action against the accused and grant us justice.
