Sir/Madam,

With due respect I the above named complainant cents to state you that :-

- 1. That the accused No: 1 is my Husband. Accused : 2 is my Brother in law. Accused No: 3 is my Sister in law.
- 2. That I am doing a small business of garments and my shop is located at Netaji Sarani, Haiderpara. My son helps me in my business and I and my son continue the business. My husband accused No: I do not provide me any sort of money for my living nor he provide, any money for my sons education. Whatever I earn from my shop I and my son spend accordingly.
- 3. That my husband (accused No: 1) every day used come late in our nome in a drunken position and after entering the hou coused No: 1 used to beat both my son and me regularly. The torture of used No: 1 is so high that I and my son feel unsafe to live with accused No: 1 accused No: 2 and 3 everyday instigate accused No: 1 to do all this as all the accused wants money whatever I earn from my shop.
- 4. That today 23/9/25 at about 1:30 PM all the accused came to my shop and asked money from me. As I cannot fulfil there lemands therefore all the

accused started throwing away all my garments and brock down different racks of garments and destroyed my shop. After that all the accused started hitting me with kicks and blows as I fell down my son came to help me even all the accused started hitting my son also very badly with kicks and blows.

- 5. That thereafter all the accused gather some wooden sticks and started hitting both me and my son with that wooden stick. All the accused tried to take money from the cash box but anyhow as I and my son shouted all the other store business people came and helped us.
- 6. That my shop has suffered a huge loss all the martials have been broke down by all the accused. Even all the accused threatened that again they will come and against they will hit me and my son as I have not provided any money to them. Now I cannot do my business and there is no time for durga puja and this time all the accused have dome this purposely so that I cannot earn any sort of money.
- 7. That all the accused are very dangerous in nature and at any point od time they can destroy my shop and even the accused No: I threated me and my son that whenever I will go home again accused No: I will start hitting me and will do all sort of torture to me. Now it becomes difficult for me to ener my own house.
- 8. That now I am in a very helpless situation. I am in a very distress position and I come before you seeking for justice. I request you to arrest the accused person immediately and to start a specific case against them together with an investigation upon which I will be helpful and thankful to you.
