Subject - Violation of Status Quo Order.

Respected Sir,

This is to bring to your kind notice that by an order dated 14.08.2025 in the case no. 40 of 2025, Ld. Special Executive Magistrate has been pleased to pass an order to maintain status quo in the below schedule property. The Police Report and B.L.R.O report has been called for.

Despite the satus quo order dated 14.08.2025, Om Prakash More has made some persons enter the disputed property claiming to be from electricity department with some electrical wires and other electrical materials and tried to install electrical meter. When I objected to their effort and informed them of the existence of status quo order of the Ld. Special Executive Magistrate, he tried to threaten me. Consequently, they left without doing any changes.

Again on 20.09.2025, two persons entered the disputed property and went into the residential house and godown. They also climbed on the roof of the godown. They were also carrying extension ladders and some electrical materials. After sometime they left.

Also I would like to draw your kind attention to the fact that on, 22.09.2025 we filed Eviction Suit against Sri OM Prakash More and others vide Title (Eviction) Suit No. 14 of 2025 before Ld. Civil Judge (Junior Division) Siliguri and on 22.09.2025 the Ld. Court was pleased to order as follows:-

ORDERED

That the instant prayer of ad-interim injunction as prayed by the plaintiffs are hereby considered and allowed in form of status-quo. Both the parties are directed not to change the nature, character and possession of suit property and also not to create any third party interest as it is till 17.12.2025."

Sir, despite the abovementioned orders of status quo, regular entry and exit of unauthorized persons in the property is noticed even today. He is trying to create third party interests in the aforementioned land.

I like to bring these facts to your kind notice with humble submission that this attempt of effecting any change in the existing electrical facilities by any authorized/ unauthorized person or trespassing in the property is in blatant violation of the order of the Ld. Special Executive Magistrate and the order dated 22.09.2025 passed by the Ld. Civil Judge (Junior Division) at Siliguri especially when both civil and criminal cases is pending with respect to the said land.
