Most Humbly, I Sri sanjib Pathak, son of Sri Sitaram Pathak, aged about 50 yrs, resident of Rajendra Nagar, coolie para, near Deshbandhu primary school, ward no 1 of SMC, PO & PS Pradhan nagar, District Darjeeling do here by inform you that today on dated 25/09/2025 around 10:30 am morning when I went to drop my son to his school at medical by my two wheeler then around 5 to 7 persons stop me at burdwan road, in front of bajaj show room, opposite goriya math, under new jalpaiguri police station and told me that they are police person and a incident of murder has been done by some goons and they do checking and they are belong from plain cloth wing of police department and said me side my vehicle and want my vehicle papers as well as they told me to open my gold chain, and fingers ring which was I keep in my neck and fingers in this fear situation I confused and started remove my gold chain and fingers rings and they told me that they have a white paper and they take my gold ornaments for keep in paper but suddenly they stop two another person and stated argued with them and when I see them they changed my gold ornaments which was kept in white paper and gave me another things raped in white paper and suggest me to keep it in my pocket when I opened it after some time then I saw that they changed my gold ornaments and I belive that they all are along to do this incident with having their plan.

My gold chain was around 23 gm and 4 finger rings was 20 gm.


