In producing herewith 01 (one) arrested accused persons namely Manish Das (23) s/o Sri Rabindra Das of Kureshi Mohalla, Dangapara, ward no. 6, PS. Siliguri, Darjeeling along with seized articles as mentioned below:.

- 1) One white color zipper plastic packet containing 300 grams of said to be Brown Sugar and marked as "Exhibit A".
- 2.One Red & white color plastic carry bag(generally used for carry of Garments) upon which written "B.L. Agarwala," Balurghat in English letter in which item no. 1 was kept in.
- 3. Cash amounting Rs. 300/- having denomination of Rs. 100 X2, 20X5.
- 4. One Apple I-Phone white color in working condition including Sim card, battery, having mobile no. 6297048193, IMEI no. 358439161627664.
- 5. One Access-125 Scooty with outnumber plate, white & Ash color in which the item sl no. 1 was kept concealed.
- I, SI Samik Paul of New Jalpaiguri PS, SPC, do here by lodge this written complaint to the effect that today on 25-09-2025 at about 19:45 hrs, I received an information from my credible source that one persons, namely Manish is illegally carrying with them a huge quantity of Brown Sugar, a controlled substance under the NDPS Act. He is expected to cross through, Central Colony area under NJP P.S for its clandestine disposal and their personal gain. This information suggests a strong likelihood of a cognizable offense under the NDPS Act being committed. If not acted immediately they would succeed to smuggle the same

I reduced the information in writing vide NJP PS GDE No. 1199, dated 25.09.2025 and I intimated the information to Shri Aviji Dutta, Inspector of Police, New Jalpaiguri PS, SPC, and after obtaining necessary order at about 19:55 hrs myself, along with a team consisting of I. Myself SI Samik Paul, along with SI Chabilal Sinha, ASI Manoj majumdar C/ Sajan Tamang, VP 13 Jamirul Islam, VP 08 Laxman Roy took departure



from New Jalpaiguri PS for Central Colony near loknath mandir area under NJP P.S along with laptop, portable printer, weighing machine, Drug Testing Kits and other necessary documents articles required for operation availing Govt. vehicle to work out the information and the same was diarized vide NJP P.S GDE No. 1200, dated 25.09.2025 and MCC No. 570/2025 dated: 25.09.2025.

At about 20:15, myself and raid team reached at Central Colony near Loknath Mandir area under NJP P.S, and met my source and he briefed me about the detail information. I then looked up for public witnesses and found 02 persons namely: 1. Ranjit Roy (34) s/o Sri Biren Roy of Surya Sen Colony, Block-E, PS. New Jalpaiguri Dist Jalpaiguri. 2. Raja Roy (29) s/o Sri Debasish Roy of Surya Sen Colony, Block-E, PS. New Jalpaiguri Dist Jalpaiguri and briefed them the information in hand in a nutshell after listening to the information they both voluntarily agreed to stand as witness for the entire process of search and seizure. Thereafter, we ambushed at Central Colony near Loknath Mandir under NJP PS. I contacted with videographer namely Tapan Mandal and asked him to came to the spot immediately and make videography of whole process of search and seizure if happen.

At about 20:40 hrs, we saw one person approaching towards Central Colony Loknath Mandir area through a scooty from Siliguri side. My source identified the person as our suspects accordingly we try to detain him but after seeing the police personals the said person increased the speed of the scooty but somehow we managed to stop him and then cordoned him and I introduced myself and the raid team members as Police personal showing our Govt. ID proofs, I then appraised him about the information in hand and started to examine him. During examination, he stated his names as Manish Das (23) s/o Sri Rabindra Das of Kureshi Mohalla, Dangapara, ward no. 6, PS. Siliguri, Darjeeling. I asked him if he had any ID proof he stated that he had no ID proof now. On further questioning, the above noted detainee made contradictory statements at different times but finally he confessed that he was in conscious possession of huge quantities of brown sugar which were packed in zipper plastic packet concealed inside his degee of his scooty. I then immediately as per provisions of section 50 of the NDPS Act, 1985 (as amended) I explained the above noted detainee and the same was given to him separately in writing stating that he have legal right to tender his personal search in front of a magistrate or a gazetted officer duly empowered under section 42 of the NDPS Act, 1985 (as amended).

I then served Notice U/S 50 of NDPS Act to the detainee whether he was willing to be searched in presence of the police Gazetted officer or any gazetted officer of other department. In reply, he made his written consent to be searched in presence of the Police Gazetted Officer. I then contact to Shri Debabrata Sengupta, Inspector of Police of New Jalpaiguri PS for his presence at PO and stand as a gazatted officer.

At about 21:05 hrs, Inspector Shri Debabrata Sengupta, Inspector of Police of New Jalpaiguri PS arrived on the spot and I introduced him as Gazetted officer to the
