6. That after that the said CHIRANJIT BARMAN, S/O Kandura Barman took me to Sevoke Kali Mandir, on 15.04.2024 and got married with me in presence of ANITA SHA, W/O Ram Sha, and ANITA BARMAN, W/O Not Known.

- 7. That after that the said CHIRANJIT BARMAN, S/O Kandura Barman, in connivance with ANITA SHA, W/O Ram Sha, and ANITA BARMAN, W/O Not Known, took me to Burirhat Bazar, P.O. Bhulki, P.S. Dinhata, District Coochbehar, Pin-736134, which is the parental house of my husband.
- 8. That my distress parents who are belong to below poverty level somehow make themselves understand for the better future of my life and in this regard ANITA SHA, W/O Ram Sha, ANITA BARMAN, W/O Not Known, both are resident of Guriyajote, P.O. & P.S. Matigara, District- Darjeeling, Pin- 734010, convinced my parents that they are very much acquainted with the family of CHIRANJIT BARMAN, S/O Kandura Barman and after few months, they will take necessary steps to organize the social marriage between me and the said CHIRANJIT BARMAN, S/O Kandura Barman.
- 9. That after few days, the said CHIRANJIT BARMAN, S/O Kandura Barman left me in his parental house at Burirhat, Dinhata and started to reside at Siliguri, District- Darjeeling.
- 10. That whenever I used to request my husband to take me with him but my husband did not bother to hear about the said matter rather started to abuse me with filthy languages and threaten me that if I dare to come to Siliguri, then he will have sold me in the brothel, situated in the state of Bihar.
- 11. That soon after marriage my husband, my father in law and mother-in-law, my brother-in-lawand sister-in-lawstarted to torture me both mentally and physically and pressurized me to bring money from my father and when I refused to comply their demands my husband namely CHIRANJIT BARMAN, S/O Kandura Barman and my father-in-law namely Kandura Barman along with my other-in-laws started to torture me, beat me mercilessly and used abusive languages upon me in respect of my skin complexion.
- 12. That my husband CHIRANJIT BARMAN, S/O Kandura Barman and my father-in-law namely Kandura Barman and mother-in-law along with my brother-in-law and sister-in-law used to demand dowry from my parental house and when I express my inability, the above named persons instigate mine in laws to torture me physically up to that limit so that I will be bound to bring enough dowry as per their demand from my parental house.
- 13. That on 30.04.2024when I was residing with my husband along with my other in-laws, suddenly started comment on my complexion and abuse me in filthy languages without any reasons and when I protested against the same then my husband banged my head on the wall and I lost my sense.

- 20. That I used to tolerate all those heinous torture by my husband CHIRANJIT BARMAN, S/O Kandura Barman and my father-in-law namely Kandura Barman and mother-in-law along with my brother-in-law and sister-in-law, hoping that one day everything will be alright but the level of torture increase day by day as very often without any realm or reason my husband caught hold of my hair and pulled me to the kitchen where he pressed my neck with an intention to kill me and surprisingly my father in law never came to rescue me inspite of hearing of my scream rather my father in law instigate my husband to kill me but somehow I escaped from their hands. Moreover, my husband always used to have forceful sexual intercourse with me by putting me on the fear of death but the true and actual fact is that my husband is an impotent person and incapable of having intercourse hence my husband always threatens me that if I ever reveal this fact to my family members then he will kill me and burn my body.
- 21. That subsequently when I was willing to conceive and shared the matter with my husband but my husband and above named father in law disagree on the same after that I found that my husband and my father in law became very aggressive also told me they do not want any child and when I protested the same my husband, my father in lawand mother-in-law started to torture me both physically and mentally and most of the time I was forced to do all house hold works intentionally, and when I wanted to take rest my husband and father in-laws slapped me hardly, and kicked me at my back with an intention to kill so that I am unable to conceive.
- 22. That 13.05.2024, I got news from my parents that one of my elder sister has been passed away and when I informed the said matter to my husband, he took me to my parental house and threaten me that if I dare to disclose any kind of torture inflicted by my husband then he will never come back to me.
- 23. That since 15.05.2024 then I was forced to live in my parental house and my husband and father in law never ever bother to take any information since then.
- 24. That presently my husband and father in law started to threat over telephone that if I do not give my husband mutual divorce then they will as I am not being able to conceive.
- 25. That recently I came to know that my husband CHIRANJIT BARMAN, S/O Kandura Barman and my father-in-law namely Kandura Barman and remarriage of my husband.

- 26. That on 13.09.2025, my husband along with the 2. ANITA SHA, W/O Ram Sha, 3.ANITA BARMAN, W/O Not Known came to my matrimonial house and started to abuse me and my family members with filthy languages and beat me mercilessly and threat me that if my mother is unable to pay a sum of Rs.50, 000/- (Rupees Fifty Thousand) only to them, then my husband will never accept me as his wife and will desert me forever.
- 27. That at present I am living in very depressed condition and I have become mentally and emotionally ruined due to the above mentioned inhuman, cruel acts and conducts of my husband namely 1.CHIRANJIT BARMAN,S/O Kandura Barman, and his father, mother, two brother-in-law, sister-in-law, all are resident of Burirhat Bazar, P.O. Bhulki, P.S. Dinhata, District Coochbehar, Pin-736134, 2. ANITA SHA, W/O Ram Sha, 3.ANITA BARMAN, W/O Not Known, both are resident of Guriyajote, P.O. & P.S. Matigara, District- Darjeeling, Pin-734010, and I am in very much fear that my above named husband and in-laws may kill me and may remarry the another lady with whom my husband is having the extra marital affair.
