Sir,

This is to inform you that I Paramita Das, aged about 37 years, daughter of Mintu Das, wife of Ramesh Prasad, resident of Tikiyapara Town Post Office, Ward No. 28 of S.M.C. P.O. Siliguri Town, P.S. Siliguri, Dist- Darjeeling, currently residing on A.P.C. Sarani, Near Bela Bakery, Deshbandhupara P.O. Siliguri Town, P.S. Siliguri, Dist- Darjeeling, begs to state you that on 16/09/2025 at around 03.00 am in the morning while I was sleeping on my room my husband namely Ramesh Prasad came back from work and started demanding Rs. 20,000/- for his expenses at that moment, being a housewife I have no financial freedom and was unable to fulfill his demand, hearing such my husband started to abuse me with filthy languages and threatened me to leave my residence immediately, hearing such I requested him not to create any chaos as it was early in the morning, despite my request he pushed me in the wall of room and started torturing me sexually by punching on my breasts and scratched my private area with force, although I was requesting him not to do so as I was getting hurt brutally but my husband without any hesitation carried on with his misdeeds and tried to make physical contact with me forcefully and brutally, witnessing such a scenario I somehow tried to free myself but my husband without any mercy started to throw punches and fists in my different vital body parts such as head, chest, stomach and he even kicked my private areas, with unbearable agony I somehow gained my strength and pushed my husband away but in the mean time he kicked me in such a way that I flew away and hit the wooden bed and faced injury on my spine and hip area, I screamed for help as because I was unable to stand up with such an injury but my husband still grabbed me by my hairs and started to drag me out of my residence and attempted to murder me as I did not fulfilled his demand for money. I somehow tried to reach my mobile phone to make contact with my mother but seeing such he got more furious and took my mobile phone and crushed it into pieces as he threatened me that he will kill me and throw my body out, hearing screams and crying my daughter namely Mehuli Prasad, aged about 13 years got up from her sleep and secretly called my mother namely Tapasi Das for help, but my mother is an elderly lady so she could not arrive immediately but she somehow came to my residence at around 05.00 am in the morning and without wasting any more time she called ambulance for me as I was still unable to move and was lying in the ground, crying in unimaginable pain and begging for help. Then within an hour at

around 06.00 am ambulance arrived at my residence and took me out on stretcher for immediate medical attention, throughout my rescue my husband locked himself in the room and was violently abusing me and my mother, but my mother without making the situation any bitter rescued me and took to Siliguri Hospital through ambulance for my treatment, I was admitted immediately (medical documents attached herewith) where I came to know I had received spine injury and many other injuries in my private areas and was advised complete 03 months bed rest and right now I am residing with my mother at her residence as I am unable to move without any support and if I tried returning to my husbands residence he would kill me as he threatened earlier.

So finding no other alternatives and being helpless I am writing you this written complaint to take appropriate/strict legal actions against my husband namely Ramesh Prasad at the earliest as he could try to kill me again and cause harm to my family anytime without having a second thought.
