With due respect I Manik Dey Son of Late Hirendra Nath Dey residing at 2 No. Panchanan Colony, within S.M.C. Ward No:01, Siliguri Junction, District-Darjeeling, West Bengal, Pin Code-734003 would like to state as follows:-

1. That my son named SUSUVAN DEY aged about 23 years was riding a two wheeler motor vehicle bearing registration No: WB-73-BP-6640, Chasis No:MB8ED11ZDP8101547, Engine no:BGA4-15086 which had been taken on rent basis from NORDUSTRA MOTORSPORTS LLP having its registered office at Golden Arcade, Opp. Rishi Bhawan, Burdwan Road, Siliguri, District: Darjeeling, Pin: 734105. It is pertinent to mention here that the NORDUSTRA MOTORSPORTS LLP had given the vehicle in rent after perusing the necessary documentation which includes driving license issued by the government being license No:WB 73-2023-0000811 and Adhar Card being No: 8156 3027 1140 of my son named Susuvan Dey.

That on 20<sup>th</sup> September 2025 at about 12:30 am or 12:50am my son met with a terrible accident with an unknown vehicle in front of Sree Communication, Opp. to Gurudwara Sevoke Road. It is pertinent to mention here that owing to that accident my son succumbed to serious injury and seeing this incident the local people rescued my son and took him to the nearest District Hospital at Siliguri. By that time I had no knowledge about the incident and as it was mid-night, being worried I called my son several times but there was no response and finally after several attempts some body received my call and informed me that such

an unfortunate event has taken place and he also informed me that my son has been taken to District Hospital, Siliguri. Upon hearing this I forthwith rushed to the hospital and when I enquired about his condition he was declared dead by the doctors of the hospital. It is also important to mention here that I could not lodge a complaint regarding such incident as this incident has left me and family deeply traumatized in due time.

I, therefore pray before you to enquire into this matter and take necessary action.
