Sub- Complaint Regarding Threat and Physical Assault at My Shop

Respected Sir,

I, Disha Das, daughter of Prasanta Das, am writing this complaint to bring to your notice an incident that occurred today inside my rented momo shop located at Siliguri Park St., Dabgram, Ward-23, Opposite Hanuman Mandir, Siliguri.

On 25th Sep at around 7:58 pm, a woman named Bulbuli Dey who lives beside of my rented shop came to my shop and started threatening me. She then attacked me with her bare hands and during the continuous assault she also picked up a chair and attacked on me with it. While I was recording this incident on my phone, she snatched my phone and threw it away with the intention to remove evidence.

Before this incident, her mother named Anita Dey had visited my shop and complained that one of my utensils had fallen into their drain. However, I assured her that I would take care of it later. Even after that I was attacked and threaten by her too. Along with them Bulbuli Dey's brother named Param Dey joined them and I was threatened and attacked by him too. I was attacked by their nails which caused scratches and injuries in my body along with filthy language and verbal abuse.

I request you to kindly take necessary action against the woman, her mother and her brother.
