This is to bring to your urgent attention that on 25.09.2025, an unknown individual made repeated phone calls to me from the mobile numbers 8069679077 and 7292896839. The caller falsely claimed to be an employee of the State Bank of India and inquired about one Ratan Roy, stating that Ratan Roy is an employee of Siliguri Municipal Corporation had taken a loan from the said bank and failed to repay it. The caller further alleged that the Municipal Corporation is now liable for the repayment of the said loan. When I informed the caller that the Corporation had no knowledge of such a loan and holds no liability for any personal financial obligations of its employees, the individual became aggressive, used abusive and filthy language, and issued threats over the phone. filthy language, and issued threats over the phone.

Subsequently, the same or another unknown individual called the Hon'ble Mayor of Siliguri Municipal Corporation, Sri Gautam Deb, from mobile numbers 9540032406 and 11-69216093, again inquiring about Ratan Roy, and using extremely offensive and threatening language, even demanding money from him. The same caller also contacted the Secretary of Siliguri Municipal Corporation, Sri Anabil Dutta, from mobile number 11-69216093, and similarly threatened him in Connection with the same matter.

Upon official verification, it has been confirmed that Ratan Roy, son of Ghuren Chandra Roy, residing at Shaktigarh Road No. 2, Near Shaktigarh School, District – Jalpaiguri, Ward No. 31 under Siliguri Municipal Corporation (Phone: 7866048835),  $\zeta$  is working as a contractual driver of the Corporation.

It is reiterated that Siliguri Municipal Corporation bears no responsibility for any personal financial transactions or liabilities incurred by its employees. These repeated calls and threats to senior officials of the Corporation have caused serious mental harassment and constitute a grave breach of peace and security. The possible involvement of the said Ratan Roy in the alleged conspiracy cannot be ruled out and requires thorough investigation.

In view of the above, I hereby request you to register an FIR, conduct a proper investigation, and take immediate legal action against the unknown caller(s) as well as Ratan Roy, under relevant provisions of law.
