With due respect I, ASI Sanjay Basunia presently serving under your kind control want to lodge this complainant against the driver of one unknown truck and produced copy of MCC. No. 1200/25 & 1201/2025 & in this regard I beg to state that on 26.09.2025 I was detailed to perform night K-21 mobile patrolling van duty in and out Siliguri PS area along with C/479. Dipak Chhetri & CV/26. Subrata Roy vide Siliguri PS. MCC No. 1200/25 Date: 26.09.2025 by Govt. vehicle Reg. No. WB/77/4887. During the night duty on date: 27.09.2025 at 03.05 hrs I received an information that one Police car meet with an accident at Burdwan Road near Jalpaimore under Siliguri PS. SPC as a result the Police vehicle got overturn. Accordingly I informed the matter to you and as per order I rushed to the spot and found that the vehicle No. WB/24K/7669 which was attached to Siliguri PS lying overturned in the middle of Burdwan Road. Accordingly myself along with force get down from the spot and recovered SI. Biswadeb Barman, C/660. Biswajit Mondal & CD/1148. Sudipta Nandi all of Siliguri PS. SPC. After recovery the Police personnel I found SI. Biswadeb Barman sustained serious blood injury on his left hand and rest two Police personnel also sustained injury. In between this as per direction of you SI. Diptajit Dhar & ASI. Subir Sen and force arrived at the spot, seeing the condition of SI. Biswadeb Barman I decided to shift him to the nearby hospital/nursing home accordingly he was shifted to STAR NURSINGHOME, Tinbatti More under PS. New Jalpaiguri by the other officers. Accordingly I asked C/660. Biswajit Mondal & CD/1148. Sudipta Nandi and they stated that at the said place at around 02.55 hrs while they were Patrolling at Burdwan road near JalpaiMore area then one truck (Unknown) from the opposite direction in the same lane rashly came towards them and CD/1148. Sudipta Nandi stated that to save the police vehicle from a head on head collision he left no stone unturned to take side but the truck dashed the Police vehicle from the left side as a result SI Biswadeb Barman sustained injury on his left hand and the Police vehicle overturned and got damaged. I shifted the two Police personnel to the Siliguri District hospital and there they were released after primary treatment. The damaged Police vehicle Reg. No. WB/24K/7669 was brought to the SPC, Head Quarters for further action. This is to mention here that the above noted Police officer and force was detailed to perform night K-22 mobile patrolling van duty in and out Siliguri PS area vide Siliguri PS. MCC No. 1201/2025 Date: 26.09.2025 and the accident occurred on 27.09.2025 at around 02.55 hrs at Burdwan Road near Jalpaimore under Siliguri PS. SPC due to the rash and negligence driving of the driver of a unknown truck.

Therefore I pray before you that a specific case may be started against the driver of the unknown truck driver for committing this accident which results damage of Public vehicle Reg. No. WB/24K/7669 and causing serious injury to the on duty Police personnel and arrange for it's investigation.
