Sir

In producing herewith following three arrested accused persons, namely 1) Hariprasad Roy (26 years) S/O Lt Subu Roy of Uttar Ektiasal Santi Colony, PS Bhaktinagar Dist Jalpaiguri, 2) Mithu Roy (23 years) S/O Sudha Roy of Khola Chand japri, near Manasha Mandhir, PS Bhaktinagar Dist Jalpaiguri, 3) Abhijit Sarkar (25 years) S/O Dilip Sarkar of Ghugumari Pipeline, ward no 37, PS Bhaktinagar Dist Jalpaiguri along with following seized articles viz:

- 1) One iron made sharp cutting hacksaw blade measuring approx 12 inches recovered from the exclusive and Conscious possession of Hariprasad Roy.
- 2) One iron made screw driver measuring approx 10 inches recovered from the exclusive and Conscious possession of Mithu Roy.
- 3) One iron made wrench measuring approx 8 inches recovered from the exclusive and Conscious possession of Abhijit Sarkar.

I, ASI Khagen Barman S/O Lt Nani Barman of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted and 10/11 others to the effect that on 27.09.2025 at 00:55hrs received a specific source information that 13/14 miscreants have assembled at PC Mittal bus terminus under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhakti Nagar PS and diarized the fact in General diary vide Bhakti Nagar PS GDE No 1398/25 dated 27.09.2025 and as per order I along with SI Srimanta Chatterjee, SI Youellepcha, ASI Dipak Karmakar, C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for PC Mittal bus terminus under Bhaktinagar PS to work out the information in hand.

At about 01.10 hrs we arrived at PC Mittal bus terminus under Bhaktinagar PS as indicated by the source we noticed that 13/14 persons assembled at PC Mittal bus terminus under Bhaktinagar PS and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 03(three) of them with deadly weapons in their possession but 10/11 persons managed to fled away from the spot taking the advantage of darkness and open place. On being asked the apprehended accused persons disclosed their name and identity as noted above. During interrogation they stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.


Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 27.09.2025 in between 01.25hrs to 01.40hrs the whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 03 (three) arrested accused persons and others kindly arrange for its investigation.
