Subject: Complaint regarding rash and negligent driving causing grievous injury to my son

Respected Sir,

I, Smt. Nandita Karmakar, wife of Late Nirmal Karmakar, residing at Nazrul Sarani, Ward No. 14, Siliguri, District Darjeeling, beg to state that on 20.09.2025 at about 1:55 p.m. my son, Bibek Karmakar, aged about 24 years, was returning from his office through Jatin Das Sarani towards Aamtala More on bike bearing registration no. WB74BT8507. At that time, one two-wheeler motorcycle that 'Meteor 350', coming from Saradamani Road dangerously in very rash, negligent and high-speed manner, hit my son near the Aamtala juncture. As a result of the collision, my son sustained grievous injuries all over his body and also started vomiting at the spot. With the help of bystanders, he was admitted to Siliguri District Hospital and thereafter shifted to Mediview Nursing Home, where he had to undergo an operation.

At the time of the accident it was not possible for my son to notice the registration number of the offending vehicle. However, on verification of CCTV footage available in the office of the Ward No. 14 Councillor, the said vehicle and the accident have been clearly captured, which establishes that the injuries were caused solely due to the rash, negligent and high-speed driving of the said motorcycle.

I therefore request you to kindly register this complaint as an F.I.R. under the appropriate provisions of law, collect and preserve the CCTV footage from the Ward No. 14 Councillor's office and other relevant sources, and take strict legal action against the accused driver responsible for the grievous injuries caused to my son.
