With due respect Sindhu Devi w/o Dharmendra Prasad aged about 29 years residing at Rajendra nagar ward no 1 cooliepara ps pradhannagar, Dist- Darjeeling would like to draw your kind attention on the following effect on 23.9.2025 at about 7.30 p.m. my husband sit on his shop suddenly the above mentioned accused no -3 Raghu Mahato came and started using filthy languages upon my husband and when he defend him the above mentioned accused person came and bit my husband here and there and the local people rescue him but soon after this incident they threatened me and my husband if came his shop they will kill him. I also mentioned here that one the same day the above mentioned accused try to burn my shop and the CCTV footage also present.

On the very next day I alone went to anchal bazar (Champasari) for purchasing vegetable the above mentioned accused persons came and asked where is my husband then when I refused to give answer they pushed me on my chest and also tore my wearing apparel and when I started shouting they fled away and then somehow I reached home.

Therefore I request you please look into this matter as soon as possible and take proper legal action against this illegal activities as because this kind of behaviour happened my reputation and dignity.
