Respected Sir,

With due respect, I, the above named Complainant would like to draw your kind attention to the following facts which are enumerated in following effects:-

1. That I am a law abiding and peace loving citizen of this Country.
2. That the above accused person being resident of our region, used to park his 4 wheeler vehicle in front end of our above referred residential house for which We had never raised any objection on consideration of very resident within our locality.
3. That on 18-09-2025, he parked his said vehicle at around 1 AM under usual manner but some sort of alarm raised from his said vehicle since 1.45AM and my daughter being heart patient found every difficulty to sleep well.
4. That accordingly I along with my son namely Manish Shaw went out of our house and found that the vehicle of the above Accused person was alarming, when I along with my said son tried to knock the Accused person family stating the above alarming dispute of the vehicle, the Accused person after hearing so as well as knowing the very issue from his balcony, under alcoholic strata desperately repudiated our request and on our frequent queries, came downstairs and started to address filthy languages to me and my family.
5. That on protest by me and my said son, he started physical assault upon me and my said son, on our shout my husband and other local people arrived at the spot and due to their intervention, my son and my own life had been saved. But the said Accused person did not bother the local people intervention, he frequently tried to attack on us with iron rods. Out of said attack, me and my said son received severe bodily injuries. (The copy of medical documents annexed herewith)
6. That subsequently We called the local police under your very judicature and after arrival of the police also, he showed his audacity as well as desperate attitude of dire consequences towards us and even tried to attack on us but due to necessary intervention of the concerned attending police personnel, he failed to succeed.
7. That after the lapse of 4 days i.e. on 23-09-2025 i.e. yesterday evening, the said Accused person along with his sponsored hooligans continuously started to address filthy languages towards our family persons and also continuously threatening us dire consequences to the effect that he would kill us and also continuously attempting to attack us with deadly weapons

and for the said reason, me and my other family members have been completely panicked to go out side of our house and for every moment We are apprehending of being attacked by the said Accused person and his associates.

8. That the Accused person assaulted me and my son with an oblique motive to promote terror within us and is continuously threatening to implicate us in false criminal cases with motive to demand landed property of our above residence as ransom cum security/protection cost for our eternal survival.
  9. That there is every apprehension of desperate attempt/s by the Accused person to harm the life and limb of me and my family members as We still refused to comply his demands and under compelling head living as house arrest due to his desperate monitoring and threat concern towards me and my family.
  10. That the Accused persons is a highly influential person having no regard to the law of the land who used to threat to the effect that law and administration are in his pocket and he could do anything against us.
  11. That out of mental trauma, the delay held to lodge the present complaint and right now under sound and stable mental health, I am filing the present complaint before your very end.
- So, it is, therefore, prayed to take appropriate legal action/s against the above referred Accused persons along with his antisocial for the proper administration of Justice.
