at about 10:00 to 10:30 pm my brother Md Izhar
age 22 years was standing by the side of the
road on Kutcha portion in front of circuit House
(National Highway) at that time one container Truck
bearing no-TN-70Y 8382 at high Speed being
driven rash & negligent manner hit my brother. As
a result of which my brother sustained injuries
and immediately he was shifted to Neotia Getwell
Hospital, Matigara and thereafter he was taken to
North Bengal Medical College and Hospital where
he died on 26/9/25 for the said injuries.
I therefore request you to take necessary
legal steps against the driver of the truck bearing
no-TN 70Y 8382 as per law.
