Dear Sir,

I Ajay Howladar, S/o amal Howladar, resident of Dakshin Chengmari, Malbazar, Dist. Jalpaiguri, lodged this complaint with the information that on 21/09/2025 at approximately 02:30 hrs to 03:00 hrs, my brother-in-law named Rakish Gain, S/o Balai Gain, was moving on a motorcycle bearing no. WB74B8592 towards NJP station to pick up his friend while he reached at Nouka Ghat Bridge at that time one another motorcycle bearing no. WB72S/2735 dashed his motorcycle by rash and negligent driving causing him to be thrown onto the side of the road, where he sustained serious and bloody injuries. His two friends namely Asim Sarkar and Shibas Bhakta who were on a separate motorcycle and going with him, took my brother-in-law to NBMC & Hospital, from there he was shifted to Desun Hospital and on 22/09/2025 he was taken to Kanoka nursing home at Kawakhali, where he succumbed to his injuries on 24/09/2025.

Asim Sarkar and Shibas Bhakta informed us about the accident and also the vehicle number of the offending motorcycle.

The post mortem of my brother-in-law was done as per Matigara PS U/D Case Number 1065/2025, dated 24/09/2025.

Due to being busy with my brother-in-laws' medical treatment and our mental breakdown after his death, the family persons were unable to lodge a complaint before you earlier.

Hence today I am submitting this written complaint to you, with a request to take appropriate action against the driver of the offending motorcycle bearing no. WB72S/2735 to ensure justice.
