This is my humble submission to you that for the past one and a half years. I have been running a small lottery and other things shop next to the Aparna group Goramore, Nayapara. Suddenly, two people opened a small lottery shop next to it. on 17/9/25. I was running a regular shop. on that day, at around 8pm, when I was closing the lottery shop, the two people who had opened a new lottery shop next to me came and tried to start a fight by saying various dirty words. We tried to convince them and asked them to leave. Then, Papam Biswas and Boron Biswas came back after ten minutes and without saying anything, suddenly threw me down, grabbed me by the hair, started beating me with stones, kicked me in the private parts, and tore my clothes. They grabbed me by the throat and took out sharp weapons. Whenever they were about to hit me, I kept screaming. At that moment, they took my necklace and money bag and run away. (20000) Rs.
